

PRIVACY STATEMENT OF PERSONAL DATA

Hereby, EGT JET EOOD with UIC 205537060, with seat and registered address at Sofia, Vrnanya-Lozen-Triangle district, 4 Maritsa Str. ("EGT JET"/ "We"), tel: +359 876147100; e-mail: office@egt-jet.com provides information about your personal data, which can be processed when concluding and executing contracts for charter flights and for fulfilling our regulatory requirements when providing our services.

WHAT PERSONAL DATA DO WE PROCESS?

The personal data that can be processed are the following:

- Names, home address, email address, telephone number, numbers and data from a passport or other valid identity document, credit/debit card data or other payment data.
- Preliminary passenger information, which includes your name, nationality, date of birth, gender, passport or ID card number, expiration date and country in which they were issued.
- Diseases of passengers who have special medical requirements and/or nutritional needs.
- Letters and e-mails that we receive from you during our communication.

When assisting by us for the purposes of applying for and obtaining a visa when travelling abroad, we could also collect and process:

- A copy of an international passport and a photo.

ON WHAT BASIS DO WE PROCESS YOUR PERSONAL DATA?

The processing of your data is necessary for:

- The fulfilment of obligations under concluded contracts for passenger transport.
- Compliance with regulatory requirements, e.g. The Civil Aviation Act and all ordinances and requirements related to the performance of aviation activity within the Republic of Bulgaria, the Regulation of the European Council EU 2027/97, the Accounting Act when issuing invoices, etc. ;
- Preservation of our legitimate interest.

FOR WHAT PURPOSES WILL WE USE YOUR DATA?

The personal data provided by you will be used for the purposes of the contract and the services offered and to comply with our obligations under applicable law.

TO WHOM CAN WE SHARE YOUR PERSONAL DATA?

EGT JET respects and preserves the confidentiality of your personal data. Personal data may be disclosed only for compliance with contractual or legal obligations and in compliance with regulatory requirements. Recipients could be transport companies, domestic and international airports, tour operators and travel agents, insurers, accounting and law firms, customs and border checkpoints, law enforcement agencies, SANS, etc.

FOR HOW LONG DO WE STORE YOUR PERSONAL DATA?

Your personal data will be stored in accordance with the statutory deadlines (including the Civil Aviation Act, the Accounting Act, etc.).

TRANSMISSION OF DATA OUTSIDE THE EU

If you enter into a contract with us for the carriage of passengers to a non-EU country, your data may be transferred outside the EU for the purpose of fulfilling the contract concluded between us. , according to art. 49, item 1, letter "b" of Regulation 2016/679 - GDPR. Without the transfer of data, it is impossible to provide our service.

YOUR RIGHTS REGARDING YOUR PERSONAL DATA

Subject to Bulgarian law, you have all applicable rights to your personal data processed by EGT Jet: access, correction, deletion, restriction of processing, etc.

You also have the right to file a complaint with the Commission for Personal Data Protection when the relevant legal prerequisites are in place.
